## Out of Catchment Enrolment Application

Applications from any person not meeting the Enrolment Management Plan criteria is considered an Out of Catchment application. Enrolment of student from outside the local catchment area is restricted to ensure that enrolments do not exceed the student enrolment capacity of the College. The College can only enrol Out of Catchment students:

- If there is sufficient spare capacity after reserving places for students who move into the catchment throughout the year;
- After considering the College's projected future enrolment growth.

Out of Catchment Enrolment Applications are considered in the order of receipt and placed on a waiting list. These applications will remain current only for the school year indicated the student wishes to enrol.
